Subject: **Mandatory Compliance with LIC Report (2024-25) observations**

In the Academic Council meeting, held on 11.6.2024, the LIC (Local Inspection Committee) reports for A. Y. 2024-25 of 110 colleges were presented for review. Upon examination, it was observed by the Board that several affiliated colleges have received negative remarks and observations in the Local Inquiry Committee.

In light of this, the university mandates immediate and strict compliance with the points raised in the LIC report to ensure the academic and infrastructural standards required by the university are met.

1. Review of LIC Report:

Each college should thoroughly review the LIC report 2024-25, paying special attention to the points marked with negative remarks or deficiencies.

2. Compliance of Negative Remarks:

The colleges should take immediate corrective actions to address all negative observations mentioned in the LIC report. A detailed action plan and report on the compliance of these points should be submitted to the **university within 08 days** from the issuance of this circular.

The college principal is directed to ensure that this circular is brought to the immediate attention of the college management and trustees of the college. The principal is also responsible for overseeing the timely implementation of corrective measures and submission of the compliance report to the university.
