

# Sub. :- Budget Estimates 2019-20 for One month since the Senate scheduled on 26-03-2019 could not be held.

Dear Sir/Madam,

The Budget Estimates for the Financial Year 2019-20 along with Revised Budget for the Financial Year 2018-19 in respect of S.N.D.T. Women's University & Institutions has already been approved by the Finance & Accounts Committee on 12-03-2019 and Management Council on 16-03-2019 respectively.

As per the Maharashtra Government Notification, Higher & Technical Education dated  $20^{th}$  March, 2019, the Senate Meeting which was scheduled on 26-03-2019 got postponed. Hence the Budget is not yet approved for the year 2019-20 by Senate.

In lieu of the foregoing & in order to keep essential operation going Hon Madam Vice-Chancellor under Section of 12(7) of the Maharashtra Public Universities Act 2016 has given approval to 10 % of the Budgetary provision of 2019-20 for the month of April – 2019.

All the Sanctions/papers/expenses should be approved by Hon. Madam Vice-Chancellor till the Budget is approved by Senate.
