

Whereas, as per the Circular no. Univ.Sec./Elec.Sen./Mgt.Rep./Prov.Elec.Roll/2022-23 dt. August 8, 2022 the Provisional Electoral Roll of the Management Representatives as prepared for the purpose of election of six Management Representatives to the Senate, under Section 28(2)(p) of the said Act, was published for the information of the concerned teachers on the Election Portal, as per Section 8(3) of the Maharashtra Public Universities (Procedure for Conduct of Election to various Authorities and Bodies of the University) Uniform Statute, 2017 (Uniform Statute No.1 of 2017).

The concerned were further requested to peruse the Electoral Roll of the Management Representatives so published on the "Election Portal" of the University and in case, any omissions or wrong entries were found in the said Electoral Roll, the same were to be brought to the notice of this office in writing on or before August 18, 2022 upto 5.00 p.m. alongwith relevant documents, for carrying out the necessary corrections. Accordingly, the corrections as reported by the concerned Management Representatives have been duly carried out after verification, as per the provision of Section 8(4) of the aforesaid Uniform Statute No.1 of 2017.

The Corrected Electoral Roll of the Management Representatives has now been accordingly prepared and published herewith by the University on the "Election Portal" on its website www.sndt.ac.in. In case of any dispute, an appeal against the said Corrected Electoral Roll shall be made to the Hon'ble Vice-Chancellor's Office on or before **1st September 2022 upto 5:00 pm**. The Hon'ble Vice-Chancellor's decision shall be final on the same.
