**C O R R I G E N D U M**

In supersession to the University Notification no. Univ.Sec./Elec.Sen./Mgt.Rep./Cont. Candi./2022-23/342 dated 21.11.2022 pertaining to notification for declaration of names of candidates who are contesting the ensuing election of Six Representatives of Management of Affiliated Colleges of Institutions to the Senate / revision of details of contesting the election of Six Representatives of Management to the Senate by the collegiums of management representatives under Section 28(2)(p) of the Maharashtra Public Universities Act, 2016

Whereas, as per the provision of Section 12(4) of the Uniform Statute No.1 of 2017, the names of the contesting candidates are required to be notified to the voters within three days after the last date of withdrawal of nominations.

Accordingly, the names of contesting candidates for the aforesaid election of six representatives of management of affiliated colleges or institutions to the Senate, under Section 28(2)(s) of the Maharashtra Public Universities Act, 2016 are hereby notified for the information of the voters, as per the provision of Section 12(4) of the Uniform Statute No.1 of 2017.



It may be noted that, as per the provision of Section 10(8) of the Uniform Statute No.1 of 2017, if the number of valid nominations does not exceed the number of vacancies to be filled, the candidates nominated shall be declared to have been elected on the date of declaration of result of election i.e. November 29, 2022 at 4.30 p.m.

As per the provision of Section 18(1) of the Uniform Statute No.1 of 2017, if any candidate is elected, nominated or co-opted to any authority or body in more than one capacity, he shall by notice in writing signed by him and delivered to the Registrar of the University within seven days of the declaration of the result of the last date of such election, nomination or co-option, as the case may, choose which of the capacities he shall hold, and such choice shall be conclusive.
