**PREPARATION OF ELECTORAL ROLL FOR ELECTION OF SIX REPRESENTATIVES
OF MANAGEMENT OF AFFILIATED COLLEGES / INSTITUTIONS FOR ELECTION
OF SIX REPRESENTATIVES OF MANAGEMENT TO THE SENATE, UNDER SECTION
28(2)(p) OF THE MAHARASHTRA PUBLIC UNIVERSITIES ACT, 2016.**


It is hereby notified for the information of the representatives of Managements of affiliated colleges / institutions that, as per the provision of Section 28(2)(p) of the Maharashtra Public Universities Act, 2016, six representatives of Management of the affiliated colleges or institutions are to be elected to the Senate from among the collegium of management representatives of the affiliated colleges or institutions out of whom one shall be from Scheduled Castes or Scheduled Tribes or Denotified Tribes (Vimukta Jatis) or Nomadic Tribes or Other Backward Classes category by rotation and one shall be woman for a term of five years before September 01, 2022 to August 31, 2027. Provided that, such representatives of management to be elected shall be the representatives of management of colleges which are accredited by National Assessment and Accreditation Council or National Board of Accreditation, as the case may be provided further that, where a management conducts one or more colleges or institutions, only one representative of such management shall be eligible for being included in collegium of management representatives.

Whereas, as per Section 2(37) of the Maharashtra Public Universities Act, 2016, "management" means the trustees or the managing or governing body, by whatever name called, of any trust registered under the Maharashtra Public Trusts Act or any society registered under the Societies Registration Act, 1860 or a company registered under Section 8 of the Companies Act, 2013 under the management of which one or more colleges or recognized institutions or other institutions of higher learning are conducted and admitted to the privileges of the University. Provided that, in relation to any college or institution established or maintained by the Central Government or the State Government or a local authority like a Zilla Parishad, Municipal Council or Municipal Corporation it means, respectively, the Central Government or the State Government or the Municipal Council or the Municipal Corporation, as the case may be.

In view of the aforesaid provision of Section 28(2)(p) of the Maharashtra Public Universities Act, 2016, it is proposed to prepare the Electoral Roll of Representatives of Management of affiliated colleges or institutions, for the purpose of election of six representatives of Management to the Senate.

All the Managements of affiliated colleges or institutions are requested to submit the details of their one representative so decided by the concerned Managing Committee or Governing Committee, as the case may be, in the prescribed proforma with attestation by the President / Chairman / Secretary of the concerned Management. The duly filled in proforma alongwith the copies of following documents should reach the office on or before **6th July 2022 upto 5.00 p.m.** The other details of the election in question will be displayed on the University website - www.sndt.ac.in ("Election Portal" may be seen)

1. Copy of the resolution of the Managing Committee / Governing Committee / Executive Committee, as the case may be, thereby deciding its representative for the purpose.
2. Copies of the recent letters of affiliation (continuation / extension / permanent) granted by the University.
3. Copy of the letter / notification of the concerned State Government thereby granting permission to the Trust / Society to open the concerned college.
4. Copy of registration of the Trust / Society.
