**DECLARATION OF RESULT OF ELECTION OF SIX REPRESENTATIVES OF  
MANAGEMENT OF AFFILIATED COLLEGES OR INSTITUTIONS TO THE  
SENATE FROM AMONG THE COLLEGIUM OF MANAGEMENT  
REPRESENTATIVES, UNDER SECTION 28(2)(p) OF THE M.P.U ACT, 2016**

All the concerned are hereby informed that, as per the Schedule of Election approved by the Vice-Chancellor, the election of Six Representatives of Management of affiliated colleges or institutions to the Senate from among the Collegium of Management Representatives of the affiliated colleges or institutions, out of whom one shall be a person belonging to Scheduled Castes or Scheduled Tribes or De-notified Tribes (Vimukta Jatis) / Nomadic Tribes or Other Backward Classes by rotation and one shall be a woman, was scheduled to be held on November 28, 2022 under Section 28(2)(p) of the Maharashtra Public Universities Act, 2016 and in accordance with the eligibility conditions for being elected as a member of the Senate, as specified by the Government of Maharashtra, in its Notification No. MNS-2016/(347/(16)/e-3 dt. 28<sup>th</sup> April, 2017 in Sr.No.1(ii) of Schedule I and as per the procedure as prescribed by the Maharashtra Public Universities (Procedure for Conduct of Elections to various Authorities and Bodies of the University) Uniform Statute 2017 (Uniform Statute No.1 of 2017)

Whereas, as per the University Corrigendum Ref. No. Univ.Sec. /Elec.Sen. /Mgt.Rep./Corri./2022-23/353 November 24, 2022, the names of contesting candidates whose nominations were found valid for the aforesaid election of six Representatives of Management were notified for the information of voters, as per Section 1 of Uniform Statute No.1 of 2017. It was further notified that, if the number of valid nominations for the said election did not exceed the number of vacancies to be filled from the respective categories (Open-04, OBC-01, and Woman-01), the candidates nominated would be declared to have been elected on the date of declaration of result of election i.e. November 29, 2022, as per the provision of Section 10(8) of the Uniform Statute No.1 of 2017.

Whereas, the scrutiny and counting of voting papers of the said election was carried out by a committee as authorised by the Registrar on November 29, 2022 at 11.00 a.m. onwards at the Churchgate Campus of the University, Mumbai - 400 020, in the presence of candidates and /or their authorised agents.

The result of the said election, after completion of scrutiny and counting on being reported forthwith to the Vice-Chancellor is hereby declared for the information of all the concerned, as per the provision of Section 16(1) & (2) of the Uniform Statute No.1 of 2017, as under:
