- vii. Students who do not possess valid PRN number and examination seat number will not be permitted to appear for the concerned examination. It shall be sole responsibility of the Principal / Director / In-Charge / HOD of the Institute / College.
- viii. The Correction / Changes in name spelling), medium, subject etc. should be carried out on the E-Suvidha Portal by the colleges with the prior permission of the Director, BCUD. No communication in this matter shall be entertained by the Pariksha Bhavan.
- ix. As per the Government of Maharashtra circular no.:Sankirn-2016/Pra.Kra.302/Vishi-3 dated 04th March, 2017, prepare and indicate the separate cover for submitting the answerbooks of physically handicapped students. Also send the covering letter in advance for the prior permission of extra time, writer, with all related documents of the concerned physically handicapped students.
- x. The Marks obtained by the students in the Internal Examinations / External Examinations / Practical / Incentive marks and marks obtained in the evaluation of Master Degree Dissertations / Projects, must be entered on the MKCL Portal latest on or before 22nd March, 2019 of U.G. Examinations.
