As per the decision taken in the online meeting held on 25th April 2022 by Education Minister, Higher and Technical Education with all Vice Chancellor's of the Universities in Maharashtra, vide Circular No. 2022/Pra.Kra.125/vishi-3 of dated 27th April 2022 decision of this Meeting is as follows:

1. All the 2nd term University Level Examinations for the Under Graduate Degree / Under Graduate Diploma / Post-Graduate Degree / Post-Graduate Diploma Programmes of (Fresh / Repeater) will be held w.e.f. **01/06/2022 by offline mode only.**
2. There will be two (2) days gap in each paper.
3. Extention of 15 minutes per hour per paper will be given to all the students.

In view of the above facts and decisions taken by Hon'ble Vice Chancellor all the concerned are here by informed that 2nd term examination of Under Graduate Degree, Under Graduate Diploma, Post-Graduate Degree, Post-Graduate Diploma Programmes, University Level Examinations (Fresh / Repeater) will be held **from 1st June 2022 onwards instead of 10th May 2022 onwards by offline mode only.**

The Link of Inward of examination forms of Post-Graduate Degree and Post-Graduate Diploma programmes is opened from dated 30.04.2022 to 10.05.2022 and with late fees @Rs.150/- for the date 11.05.2022 and 12.05.2022.

The schedule for entry of Internal and Incentive marks on DU Portal and all the other points mentioned in the earlier circular will remain same.
