Institute.

Sir/Madam,

As you aware that Higher & Technical Education, Govt. of Maharashtra has given instruction not to form the Student Council at College & Institute level.

In this context, as NAAC Committee recommendation & suggestion, the University has decided to constitute a student association called "Abhivyakti Mandal" at College/Department/Institute level to govern & manage the students' activities and programs.

Therefore, the Merit Student or Best Student (based on Scholastic & co-curricular performance report) of the Division/Class will be nominated as a "Abhivyakti Girl" of the class. Each Abhivyakti Girl will select their college /Institute level "Abhivyakti Girl" & formed the "Abhivyakti Mandal" as well.

For Post Graduate Departments Merit Student/Best Student (based on Scholastic & Co-curricular performance report) will be nominated as Abhivyakti Girl from the Department/Institute.

The University level 'Abhivyakti Girl' will be selected from Department and College level Abhivyakti Girls.

This scheme of Abhivyakti Kendra / Katta is made **for the student, by the student, of the student**, SNDT Women's University.

The "Abhivyakti Kendra / Katta" of each college will be run by the 'Abhivyakti Girl' & "Abhivyakti Mandal".

For Campuses, the 'Abhivyakti Katta' (अभिव्यक्ती कट्टा) will be govern by "Abhivyakti Campus Mandal" under the control & supervision of Campus Incharge.

"Abhivyakti Campus Mandal" will be the Students Committee of Department, Institution & College level selected "Abhivyakti Girls".

After selection of University level "Abhivyakti Mandal", the Hon'ble Madam will address them for future plan & action of the Mandal.

The Principals/HODs/Directors should follow the procedure mentioned in the circular to select 'Abhivyakti Girl' and establish 'Abhivyakti Katta' and 'Abhivyakti Mandal' at each College /Department/ Institute/ Campuses.

Hon'ble Madam Vice Chancellor has planned to open the "Abhivyakti Katta" specially for students at Churchgate Campus, Juhu Campus, Pune Campus exclusively.

Dean, Department of Students' Development will be the authority to report, manage&execute of different policies &activities of Students Development / welfare through "Abhivyakti Katta".

In short "अभिव्यक्ती कट्टा" - "विद्यार्थिनींच्या हक्काची जागा" is a concept behind the "Abhivyakti Mandal".

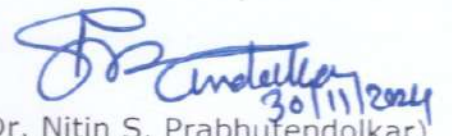
You are requested to kindly prepare the plan of action for selection of "Abhivyakti Girl" of your Institute/ College/ Department level and send the name of one "Abhivyakti Girl" to the University for the selection of University level "Abhivyakti Girl" and "Abhivyakti Mandal" as well. The filled in proforma should be send on the mail [dsw@sndt.ac.in](mailto:dsw@sndt.ac.in) latest by December 16, 2024. After this date the application will be not entertained.

The University level "Abhivyakti Girl" & "Abhivyakti Mandal" will be established on December 21, 2024. One "Abhivyakti Girl" per College & Department should be present for University level selection & formation of "Abhivyakti Mandal" on December 21, 2024 at 11.30 am at committee room, Churchgate Campus with their documents.

**Note: The Travelling expenses of students should be borne by the college/ Department from their own budget.**
