B. SCOPE OF WORK:-

The Consultant will provide professional services in respect of the following works:

1. Review the existing structure and the available existing drawings.
2. Check for any additions and alternations by comparing the available drawings and the corresponding structure. If require, Client's input will be sought, as and when required, to ascertain the validity and chronological history of the changes.
3. Survey the building from inside and outside, mark the observations and distress on the available plans. Whenever possible, identify the most probable cause for the distress to the structural members. Primary mode of the survey will be visual - a light hand-held hammer, chisel or screw drive, etc., may be used to identify the state of the structural members. If require, /Client's input will be sought, as and when required, to ascertain the validity and chronological history of the distress / damages observed.
4. The detail Structural Audit Report will be prepared based on the above will include the following:
 - Brief description and history of the structure.
 - Based on the Client's feed-back, history of repairs, additions and alterations to the building.
 - Any critical observations, which needs Client's immediate attention in terms of repair to the structure of modification in the loading arrangement.
 - List of distresses and damages observed along with the probable causes for same, if possible.
 - Overall, and if required, specific remark on the health of the structure with actual Photographs of conducted test.
 - Recommendations for further investigation, testing, repairs, strengthening, etc., along with the urgency for the same.
 - NDT test should be conducted.
 - Necessary test required like core sampelling to check the health of building wherever required.
 - The report should be in format of B form which needs to be submiited to MCGM.
 - Bidders should visit the site before quote the rate.
